Proceedings:

At the outset, on behalf of Ms. Bharati Pradhan, Convner, Indira Bhattacharya, Co-ordinator extended a hearty welcome to all the members. As per the previous practice, he/she requested Ms. Suchitra Rath, Parent member of Class VIII to preside over the meeting.

1. Proceedings of the meeting held on 25.11.2017 were read out and confirmed.
2. The important achievements of the school were appraised before the PTCC and all the members congratulated the efforts of the students and teachers.

3. As an important issue like discussion on Budget is involved, with permission of the committee, the Principal took over the charges for presentation of the Budget. The proposed Budget Estimate for the year 2018-19 was circulated to the members of PTCC in advance. On comparison of Salary Estimated for 2018-19 and Salary Estimated for 2017-18, the increase is coming to 17.87% without enhancing the expenditure in any heads. Some parents asked clarifications on income & expenditure of Books, and expenditure on Insurance, Building (R & M) Furniture & Fixture (R & M), Furniture & Fixture (Purchase), safety measures and scholarship the same was clarified. After a long deliberation it was unanimously recommended to increase the school fees by 10% over and above the fee structure of 2017-18 as per the guidelines of the Hon'ble Supreme Court and recommendation of the Fee Structure Committee. However, it was resolved to send the Budget with detailed information to the parent members particularly on the above five heads for their reference.
4. Other points with permission of the Chair:
- (i) The proposal for enhancement of Special Development Fee from Rs.25,000/- to Rs.27,500/- for the new entrants for the session 2018-19 was accepted.
- (ii) The proposal for enhancement of Bus fees from Rs.10,000/- to Rs.11,000/- per child per annum from the session 2018-19 was accepted.
- (iii) The proposal of the Health & Family Welfare Department, Govt. of Odisha to conduct Measles-Rubella (M.R.) vaccination programme for the children of age between 4 years to 15 was accepted.
- (iv) The proposal for introduction of Embibe Test series for all Science students in Class XI & XII from the session 2018-19 @ Rs.1000/- per student was discussed and resolved to implement the same from the session 2019-20 with prior information to the parents.

The meeting ended with a vote of thanks to the Chair and members present.
