Greetings of the Day!

This is to inform you that the marks for Pre-Board Examination-1 have been uploaded to the ERP. You are requested to check the ERP through your login ID to view the marks of your ward. As per our earlier practice, the Admission Committee has proposed to start the admission process early so that the students can utilize the transition gap from completion of the exam to declaration of results. They can attend class-XI before the declaration of the Board results.

The Admission Committee will accommodate all the students of Class X of the school in Class XI for the session 2025-26 per the criteria in Notice No.DAV(CSP)/4022/2024 dated 11/11/2024 based on the performance of the students in the Pre-Board Examination-1 and subsequent examinations to be conducted by the school/Board. The counseling-cum-registration proforma shall be issued to the students on 28.12.2024 from 3.30 p.m. to 5.00 p.m. in the following rooms.

Parents interested in counseling-cum-registration for their wards into **Class XI Science, Commerce & Humanities** are requested to remit an amount of **Rs.20,000/- (Rupees Twenty Thousand)** only towards the provisional fee of 1st Quarter through online payment under miscellaneous fee browsing the school website www.davcsp.org on or before **05.01.2025** which will be adjusted against the school fee for 2025-26. After provisional admission in the desired stream, if any student does not continue or leaves the school, the provisional fee of **Rs.20,000/-** will be forfeited. The details of the fee structure for the session 2025-26 will be notified in due course.

The parents are also requested to submit the counseling-cum-registration proforma duly filled per the criteria already communicated, along with the fee receipt for **Rs.20,000/-** towards the provisional fee in the school office on or before **05.01.2025**. To ascertain the continuance of any student in the school, he/she must register in any stream i.e. Science/Commerce/Humanities, as per his/her eligibility criteria, which can be upgraded based on marks to be obtained in subsequent examinations (Sahodaya Pre-Board/Board Examination). If any student/parent does not submit the counselling-cum-registration proforma, it will be assumed that he/she is not interested in continuing in the school, and his/her claim for a seat in the school will be ceased.

The school has published the advertisement inviting online applications for the DAV Admission Test(DAT), CSP-2025 from 25.12.2024 to 19.01.2025 for admission into Class XI Super-40/Prime-40(Purely Residential programme) and Special Sections without prejudice to the interest of the internal students. The DAV Admission Test(DAT), CSP-2025, shall be conducted on 23.01.2025(Thursday). The internal students interested in those classes may register online and appear for the DAV Admission Test.
