2. At the time of admission, the parents must produce the Original Birth Certificates of their wards issued by the Registrar of Birth and Death for verification.
3. The parents are also requested to produce a printout of the registration form along with a photocopy of the applicant's Birth Certificate and Aadhaar Card and the parents' Aadhaar Card at the time of admission. The parents under Alumni category are required to produce the pass certificate of Class X/XII.
4. Both parents must be present at the time of admission with the requisite fee in the form of a Bank Draft. They are requested to wait until their turn comes for counseling/admission as per their position in the list.
